

TERMS & CONDITIONS

- 1 In order to be valid, all forms must be filled out completely, correctly and legibly.
- 2 This offer is valid for Monday, Tuesday or Wednesday departure dates only.
- 3 To register, this certificate must be received by CBE prior to the expiration date printed on the reverse. Upon registration, you will be sent a reservation request form with the toll-free telephone number to call and instructions on how to make your reservation. You will have one year to utilize your accommodations from the date your reservation request form is issued.
- 4 Departures are from Atlanta, Austin, Boston, Burbank, Chicago (Midway or O'Hare, as assigned by CBE), Cleveland, Dallas, Denver, Detroit, Hartford, Houston, Indianapolis, Kansas City, Little Rock, Minneapolis, Nashville, New York (Newark, LaGuardia or JFK, as selected by CBE), Oklahoma City, Omaha, Ontario, Philadelphia, Pittsburgh, Portland, Raleigh/Durham, San Antonio, San Diego, San Francisco Bay Area (Oakland, San Francisco or San Jose, as assigned by CBE), Seattle, St. Louis or Washington Dulles.

Frequently Asked Questions

"What is included in this offer?"

This offer includes round-trip air transportation for two to Las Vegas and two nights accommodations. The accommodation property may require you to post a credit card or deposit for some of these expenses.

"Why must I give at least 60 days advance notice?"

"Can I make my reservation by telephone?"

Yes, the toll-free telephone number to our reservations department will be provided to you upon registration of your certificate.

"What is meant by restricted to certain dates?"

CBE utilizes off peak dates in order to assure enough availability for our travelers. This means that holidays, conventions and other peak travel periods are not available.

"What applicable taxes am I responsible for?"
